	AG2 and Seniors - All gymnasts in good standing with the correct age and holding a valid FIG licence until the end of the event, may participate.  The LOC will be responsible for checking the validity of all gymnasts Licences.  No gymnasts will be accepted without a valid License at the deadline of the Nominative Registration.				
	NG, ND & AG1 and Aerobice Dance & Aerobic Step categories – without FIG licence (no FIG licence is needed).				
CATEGORIES	NG, ND, AG1, AG2, Seniors: IW / IM / MP / TR / GR ND, AG1, AG2, Seniors: AD / AS				
JUDGES AND JURIES	All judges must have a current valid FIG brevet at the time of the event, for the respective discipline.
