JUDGES AND JURIES	All judges must have a current valid national or FIG brevet at the time of the event, for the respective discipline. Each participating federation must send at least 1 FIG judge or 1 National judge. Failure to do so, will result in a fine of 500 € to be paid to the LOC until the Nominative Registration (19 th August, 2021). The number of Judge's panels may be decided by the Organizing Member Federation depending on the number of participating competitors and judges.

	The competition consists of Qualifications and Finals in Age Groups (SEN, AG2, AG1) and all categories. There will be no qualification in age group NG and ND and there will be no qualification if less than 8 units in categories.		
	QUALIFICATIONS: There is no limit on the number of participants per category and nation in the Qualifications.		
	FINALS: The top 8 (eight) competitors from the Qualification in each Age Groups (SEN, AG2, AG1) and category (IW, IM, MP, TR, GR, DA, ST) will take part in the Finals (maximum two per category and nation) plus 3 (three) competitors from organizing Federation in each category if their not qualified to the finals.
