FEDERATIONS INVITED	The Organizing Member Federation will invite all FIG Member Federations in good standing.						
AGE LIMITS	<p>AG: 12-14 years, JUN: 15-17 years, Seniors: 18 year and older</p> <p>All gymnasts must have an FIG licence valid until the end of the event.</p> <p>For Age Group categories (not sanctioned) see the part Additional information at the end of directives.</p>						
CATEGORIES	<p>AG, JUN, Seniors: IW / IM / MP / TR / GR</p> <p>AG, JUN, Seniors: AD / AS</p>						
JUDGES AND JURIES	<p>All judges must have a current valid FIG brevet at the time of the event, for the respective discipline.</p> <p>Each participating federation must send at least 1 FIG judge. Failure to do so, will result in a fine of 500 € to be paid to the LOC until the Nominative Registration (18th March, 2022).</p> <p>The number of Judge's panels may be decided by the Organizing Member Federation depending on the number of participating competitors and judges.</p> <p>The Juries will be set by a draw for the judges present at the event. The priority will be given to the judges of the highest category.</p>

ENTRY FEES	<p>The Entry fees for the different categories in each Age Group are as follows: IW & IM: 20 € / MP 30 € / TR: 50 € / GR: 60 € / DA: 80 € / ST: 80 €</p> <p>100% of the Entry fee must be paid to the bank account of the Czech Gymnastics Federation on 18th February, 2022 at the latest (the deadline for the Definitive Entry).</p>						
COVID-19	<p>Besides the medical guidelines for the particular event, FIG also requires all the participants to follow the standard precautions.</p> <p>The FIG requires all participants, judges and officials to take standard precautionary measures, such as frequent hand-washing, wearing masks or face coverings at all times and keeping a physical distance of at least 1,5 metres whenever possible.</p> <p>The only situation in which safety distance does not have to be respected is when a coach provides assistance (catch, lead, spotting) during an athlete's performance. This phase must be kept as short as possible and the assisting person is obliged to wear a mask throughout.</p> <p>Gymnasts do not need to wear a mask or face covering while they are performing at the training venue or on the FOP and keeping a physical distance of at least 1,5 metres whenever possible.</p> <p>LOC is cooperating and consulting with the Czech health authorities.</p> <p>All participants have to follow the Anti-Covid measurements. ACCREDITATION	<p>The accreditation will take place at the venue "SC - Řepy" upon arrival of the delegations. The accreditations will be handed to the Head of delegation. Detailed information about the accreditation procedure will be given with the Work Plan that will be distributed to all participating Federations on 25th March, 2022 at the latest.</p>
EVENT FORMAT	<p>The maximum number of units per category and nation in each Age Group category is 8, except for the Organizing Federation.</p> <p>The competition consists of Qualifications and Finals in Age Groups (SEN, JUN, AG) and all categories. There will be no qualification if less than 8 units in categories.</p> <p>QUALIFICATIONS: The maximum number of units per category and nation in each Age Group category is 8, except for the Organizing Federation.</p> <p>FINALS: The top 8 (eight) competitors from the Qualification in each Age Groups (SEN, JUN, AG) and category (IW, IM, MP, TR, GR, DA, ST) will take part in the Finals (maximum two per category and nation) plus 2 (two) competitors from organizing Federation in each category if they are not qualified to the finals.</p> <p>AD and AS: only finals, no Qualification round.</p>

VISA	<p>Please verify immediately with your travel agent or the Czech Republic Embassy or Consulate in your country if a visa is required for your travel to the Czech Republic. The LOC will be happy to assist each Delegation member with an official invitation letter, provided that the request is made before 18th March, 2022 to the Czech Gymnastics Federation.</p> <p>The request must include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the Delegation Member as well as the city the visa application support letter must be sent to.</p>
INSURANCE	<p>The Host Federation, the LOC and the FIG will not be held responsible for any liabilities in case of accidents, illness, repatriation and the like.</p>

	<p>The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and for repatriation for all the members of their Delegation.</p> <p>The LOC will verify the insurance upon arrival of the delegation members (e.g. cover note or photocopy of the valid policy). Delegation members with insufficient insurance cover must inform the LOC in advance.</p> <p>The LOC will subsequently offer insurance at the Federations own charge. Information about the cost of the insurance will be given with the Work plan.</p>
INTERNATIONAL TRANSPORTATION	<p>The invited participating federations must pay for the travel costs of their delegation members. The Travel Schedule Form must be returned to the LOC by 18th March, 2022. If person from one delegation/Federation are arriving and departing with different flights, please fill in separate travel forms for each group of persons and indicate on the travel form the exact number of persons.</p>

ADDITIONAL INFORMATION	<p>ND and NG Competition: (not sanctioned) – IW / IM / MP / TR / GR ND: AD</p> <p>Age limits: NG: 6-8 years, ND: 9-11 years</p> <p>Delegations have to prove the age of the gymnasts (FIG licence, national licence, passport, personal ID, insurance, etc.), if requested by LOC.</p> <p><u>For ND, NG Competition only:</u></p> <ul style="list-style-type: none"> - There will be no qualification in age group NG and ND. - Judges: For ND, NG Competition national judges with highest national category may be also accepted. The LOC may require the proof of the national judging brevet or ask respective NF for confirmation the national category. <p>Detailed information about the program, schedules and organization of the event will be given to the Work Plan and will be send to all participating Federations after the nominative registration deadline, on 25th March, 2022 at the latest.</p>
