	The maximum number for the Qualifying rounds is four (5) per category and nation, except Slovakia. There will be no qualification if less than 8 units in categories (IW/IM/MP/TR/GR).
	FINALS: National Development, Age Group, Juniors and Seniors: Each final (IW, IM, MP, TR, GR): maximum of ten (10) units: 7 best foreign units (max. 2 per nation) + 3 Slovak units (maximum).

VISA	Please verify immediately with your travel agent or the Slovak Embassy or Consulate in your country if a visa is required for your travel to Slovakia. The Organizing Committee will be happy to assist each Delegation member with an official invitation letter, provided that the request is made before 11th FEBRUARY 2024 to the LOC. The request must include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and
	departure dates of the Delegation Member as well as the city the visa
COVID 19 FIG Guidelines	application support letter must be sent to. The LOC should follow local guidelines in management of COVID-19. The LOC must facilitate COVID-19 testing for delegations when it is required to have a negative test for return to their country.
	Alldelegation must bring Negative PCR test results 48h before the time of arrival in Slovakia.
	LOC is cooperating and consulting with the Slovak health authorities. All participants have to follow the Anti-Covid measurements. The Heads of the Delegations and the coaches are responsible for their delegation's members.

INSURANCE	The Host Federation, the Organizing Committee and the FIG will not be held responsible for any liabilities in case of accidents, illness, repatriation and the like. The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and for repatriation for all the members of their Delegation. Basic insurance (sickness, accident and repatriation) in your country of residence is compulsory in order to be able to benefit from coverage by FIG IMSSA subsidiary insurance. SAFEGUARDING	 The LOC will verify the insurance upon arrival of the delegation members (e.g. cover note or photocopy of the valid policy). Delegation members with insufficient insurance cover must inform the LOC in advance. The LOC will subsequently offer insurance at the Federations own charge. Information about the cost of the insurance will be given with the Work plan. From the official event day of arrival until the official day of departure, participants (gymnasts, coaches, judges and any other delegation members) have the possibility to contact by phone or e-mail the LOC Safeguarding Officer in case of harassment and abuse of any type or if they are worried and do not feel comfortable.
INTERNATIONAL	 The information regarding the LOC Safeguarding Officer will be communicated upon arrival of the delegations on site. In addition, posters of the "10 Golden Rules of Gymnastics", the FIG campaign to raise awareness about youth protection in Gymnastics, will have to be displayed in several locations, including training and warm-up halls and public zones. The invited participating federations must pay for the travel costs of
TRANSPORTATION	The Travel Schedule Form must be returned to the LOC by nominative registration 11 th MARCH 2024.
LOCAL TRANSPORTATION	LOC will provide free of charge transport from Bratislava Airport, Bratislava Railway Station, and Bus Station to the hotels and back, for the national delegation who booked their accommodation through the LOC. Transport form must be returned to the Slovak Gymnastics Federation by the date of nominative registration 11 th MARCH 2024. Additionally, the cost of 35 € (per Delegation Member per 1 way) for the local transportation from Vienna airport to Bratislava must be paid to the Slovak Gymnastics Federation by nominative registration 11 th MARCH 2024.

MEALS JUDGES AND JURIES	During the competition, a lunch and a dinner are available at VIVO SHOPING MALL near by Multifunctional Sports Hall (competition venue). All judges must have a current valid FIG brevet at the time of the event,
JUDGES AND JURIES	For the respective discipline. Each participating federation must send at least 1 FIG judge. Failure to do so, will result in a fine of 500 € to be paid to the LOC until the Nominative Registration (11 th March, 2024).
	The number of Judge's panels may be decided by the Organizing Member Federation depending on the number of participating competitors and judges.
MUSIC	The Juries will be set by a draw for the judges present at the event. The priority will be given to the judges of the highest category. In order to simplify the management of the music and to limit the technical problems the federation are asked to submit the music in MP3 format

ADDITIONAL INFORMATION	 The Draw for the starting order for Qualifications and Finals will be done in advance by the Technical Committee of Slovak Gymnastics Federation based on the Definitive entries and will be distributed to all Nations. Detailed information for the program, schedules and organization of the event will be given to all participating federation with the Work Plan. Work Plan which will be distributed to all registered federations not later than 30th MARCH 2024. Delegations have to prove the age of the gymnasts (FIG license, national license, passport, personal ID, insurance, etc.), if requested by LOC. 			
	An International event for AG (12-14) and ND (8-11) for the cates IM/ MP/ TR/ GR / AD as well as Junior and Senior in AD and AS be held (not FIG sanctioned). Conditions, number of units, dead prices are the same as for the Seniors and Juniors.			

For ND, AG competition only:

National judges with highest national category may be also accepted. The LOC may require the proof of the national judging brevet or ask respective NF for confirmation the national category.
