QUALIFICATIONS  The participation in Qualifications is limited to the units mentioned in the paragraph "Size of delegation" except for the Organizing Federation. There is no limitation to the number of units for the Organizing Federation.  FINALS  The top 8 (eight) competitors from the Qualifications in Seniors and Juniors in each category (IW, IM, MP, TR, GR, AD) will take part in the Finals (maximum two per Category and Nation). MEDICAL SERVICES	During all days – trainings and competition official medical persons who will be in the training and competition halls will be provided by the LOC.
VISA	Please verify immediately with your travel agent or the <b>Bulgarian</b> Embassy or Consulate in your country if a visa is required for your travel to <b>Bulgaria</b> . The LOC will be happy to assist each Delegation member with an official invitation letter, provided that the request is made before <b>6</b> <sup>th</sup> <b>of August 2025</b> to the email of the OC – <u>aerobicub@gmail.com</u> The request must be made using the official form and include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the Delegation Member as well as the city where the visa application support letter must be sent to.
INSURANCE	The Host Federation, the LOC and the FIG will not be held responsible for any liabilities in case of accidents, illness (including COVID-19), repatriation and the like.  The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and repatriation for all the members of their Delegation.  Basic insurance (sickness, accident and repatriation) in your country of residence is compulsory in order to be able to benefit from coverage by FIG IMSSA subsidiary insurance. The LOC will verify the insurance coverage upon arrival of the delegation members (e.g. cover note or photocopy of the valid policy). The insurance must be valid at least starting from the arrival day of the delegation and must last for the delegations' entire stay.  The LOC will subsequently offer insurance at the Federations own charge if requested in advance. Based on the request the LOC will provide information about the cost.
SAFEGUARDING	From the official event day of arrival until the official day of departure, participants (gymnasts, coaches, judges and any other delegation members) have the possibility to contact by phone or e-mail the LOC Safeguarding Officer in case of harassment and abuse of any type or if they are worried and do not feel comfortable.  The information regarding the LOC Safeguarding Officer will be communicated upon arrival of the delegations on site.  In addition, posters of the "10 Golden Rules of Gymnastics", the FIG campaign to raise awareness about youth protection in Gymnastics, will have to be displayed
INTERNATIONAL TRANSPORTATION	in several locations, including training and warm-up halls and public zones.  The invited participating Federations must pay for the travel costs of their delegation members.  The Travel Schedule Form must be returned to the OC @ aerobicub@gmail.com and to the LOC @ aerobic-amd@abv.bg by 3 <sup>rd</sup> of September 2025. If persons from one delegation/Federation are arriving and departing with different flights, please fill in separate travel forms for each group of persons and indicate on the travel form the exact number of persons.
LOCAL TRANSPORTATION	Arrival and departure – Sofia or Plovdiv: The LOC may provide transportation to all delegation members, who have booked their accommodation through the LOC, from and to Sofia or Plovdiv airport, railway station or central bus station to the official hotel in Plovdiv and back on the official arrival (8 <sup>th</sup> of October 2025) and departure days (13 <sup>th</sup> of October 2025). The cost of the local transportation from Sofia airport, railway station or central bus station to Plovdiv (appr. 130 km) is 29 euro one way (58 euro both ways). This transportation should be requested with the official Travel form sent to the OC and LOC and should be paid to the LOC not later than 3 <sup>rd</sup> of September 2025. The transportation costs cannot be reimbursed. For those delegations or member of delegations that do not arrive or depart on the official day, upon request, the LOC may arrange additional transportation. The cost for it depends on the number of people, the date and time. Please, send your request to

An International event for:

- Youths for the categories IW/ IM/ MP/ TR/ GR/ AD and
- ND for the categories IW/ IM/ MP/ TR/ GR will also be held (not sanctioned). For those age groups an exception in the age is possible only for TR, GR and AD categories as follows:
- TR category max one of the gymnasts could be from a lower age group In Youths 12-14 (born 2014 2016) and in ND 9-11 (born 2017 2018)
- GR category max two of the gymnasts could be from a lower age group In Youths 12-14 (born 2014 2016) and in ND 9-11 (born 2017 2018)
- AD category max three of the gymnasts could be from a lower age group
   In Youths 12-14 (born 2014 2016)

Conditions, number of units, deadlines and prices are the same as for the Seniors and Juniors. No FIG license is requested.

The Draw for the starting order for Qualifications and Finals will be done in advance by the Technical Committee of Aerobic Union Bulgaria based on the Definitive entries and will be distributed to all Nations.

More information will be given with the Work Plan which will be distributed to all registered federations not later than 29<sup>th</sup> of September 2025.
