Event Format:	The Austrian Aerobic Open 2025 will have Qualifications and Finals as follows: <u>Qualifications:</u> The number for the Qualifying rounds unlimited. There will be no qualification if less than 8 athletes/units in categories. <u>Finals:</u> National Development, Age Group, Juniors and Seniors: Each final (IW, IM, MP, TR, GR): maximum of ten (10) units: 7 best foreign units (max. 2 per nation) + 3 Austrian units (maximum).

Medical Services:	Official medical person will be provided by the LOC and will stay in the hall every day.

Visa:	Please verify immediately with your travel agent or the Austrian Embassy or Consulate in your country if a visa is required for your travel to Austria. The Organizing Committee will be happy to assist each Delegation member with an official invitation letter, provided that the request is made before <b>31. August 2025</b> to the LOC. The request must include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the Delegation Member as well as the city the visa application support letter must be sent to.
Insurance:	The Host Federation and the Organizing Committee will not be responsible for any liabilities in case of accidents, illness, repatriation and the like. The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and for repatriation for all the members of their Delegation. The LOC will verify the insurance upon arrival of the delegation members (e.g. cover note or photocopy of the valid policy). Delegation members with insufficient insurance cover must inform the LOC in advance.

Judges and Juries:	Every Nation should register at least one judge with a valid FIG Brevet for the current cycle. Failure to do so may result in a fine of 500 Euro to be paid to the Local Organizing Committee in order that the LOC invites neutral judge/s. The fine for missing a judge should be paid to the LOC no later than 30. September 2025. The number of Judge's panels will be decided depending on the number of participating competitors and judges. The Juries will be set by a draw from the judges present at the event. The priority will be given to the judges of the highest category.
International Transportation:	The invited participating federations must pay for the travel costs of their delegation members.
Local Transportation:	Delegations can fly to the International airports Innsbruck (AT), Salzburg (AT) or Munich (DE). The LOC can provide an airport transfer or a train station transfer to the hotel and at the time of the stay a local transport from the hotel to the competition hall. However, only the airport transfer or the local transport can be selected. The airport or train station transfer can be used for arrivals on 30. or 31. October 2025 and departures on 02. or 03. November 2025. Please register with the <b>summary form</b> . The summary form must be returned to the LOC by <b>31. August 2022</b> .

	The Accommodation Form must be returned to the LOC by <b>31. August 2025</b> at the very latest. Since there are only a certain number of rooms per category, the Hotel rooms will be allocated on a "first come, first serve" basis. The delegations must pay for the accommodation expenses of their delegation
	<ul> <li>members.</li> <li>All hotels are located within a maximum radius of 15 km.</li> <li>The costs for the accommodations must be paid to the LOC as follows:</li> <li>50 % of the payment – 31. August 2025</li> <li>100 % of the payment – 30. September 2025</li> <li>Cancellation/Reimbursement Policy:</li> <li>Until 31. August 2025 – 50 % of the payment</li> <li>After 30.
