<b>PARTICIPATION</b>	The International Open Competition consists of qualifications and finals. There will be qualifications only for the categories and age groups with more than 9 participants. In case of a tie in any place, the tie-breaking rules are as set by FIG. Participation in the finals:

	<p>The top eight scores per category and age group, will qualify for the Finals. In case of a tie at any place, the tie-breaking rules are the FIG World Championships Rules.</p> <p>The LOC may cancel the competition in the respective category if at the time of the definitive entry, there are less than 3 countries registered in a category. In case of such a cancellation, the LOC must reimburse, in full, the entry fee and payments made for accommodation.</p> <p>Should flights have to be cancelled due to the above, the risk is at the charge of the participating member Federations.</p>									
<b>SIZE OF THE DELEGATION AND FIG LICENSE</b>	<p>The number of participants by nation, category and age group is not limited. All <b>AG1</b> (12-14 Years), <b>Juniors / AG2</b> (15-17 years) and <b>Seniors gymnasts in good standing with the correct age and holding a valid FIG license until the end of the event, may participate.</b></p> <p>The LOC will be responsible for checking the validity of all gymnasts Licenses. No gymnasts will be accepted without a valid FIG License at the deadline of the Nominative Registration.</p>									
<b>AGE LIMITS</b>	AG1: 12-14 Years / AG2-Juniors 15-17 years / Seniors 18 + years									
<b>CATEGORIES</b>	IW / IM / Mix Pair / Trio / Group (all age limits) / Aerodance (AG2 & SNR) / Aerostep (SNR)									
<b>JUDGES &amp; JURIES</b>	<p>The number of Juries (judges' panels) may be decided by the Organizing Member Federation depending on the number of participating competitors and judges.</p> <p><b>All judges must have a current valid FIG brevet.</b></p> <p>The Juries are set up by a draw and directed by the Technical Delegate from the judges present at the event. Priority will be given to the judges of the highest category. If, on the day of the competition, there are no sufficient numbers of judges in the requested categories, the Technical Delegate may take whatever action needed to secure the running of the event. Each participating federation must provide minimum one judge Cat. 1, 2, 3 or 4 with current valid brevet. Failure to do so, will result in a fine of Swiss Francs 2'000.- to be paid to the LOC until the Definitive Registration date (14-01-2018).</p>									
<b>REGISTRATION DEADLINES</b>	<p>Provisional, Definitive and Nominative Registrations must be completed by sending the composition of the delegation to the LOC. <b>VISA</b>	<p>Please verify immediately with your travel agent or the <b>Portugal</b> Embassy or Consulate in your country if a visa is required for your travel to <b>Portugal</b>. The Organizing Committee will be happy to assist each Delegation member with an official invitation letter, provided that the request is made before <b>21, January, 2018</b> to the LOC. The request must include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the Delegation Member as well as the city the visa application support letter must be sent to.</p>
<b>INSURANCE</b>	<p>The Host Federation, the Organizing Committee and the FIG will not be held responsible for any liabilities in case of accidents, illness, repatriation and the like.
