PARTICIPATION	The International Open Competition consists of qualifications and finals. There will be qualifications only for the categories and age groups with more than 9 participants. In case of a tie in any place, the tie-breaking rules are as setby FIG. Participation in the finals: The top eight units per category and age group will qualify for the Finals. In case of a tie at any place, the tie-breaking rules are the FIG World Championships Rules. The LOC may cancel the competition in the respective category if at the time of the definitive entry, there are less than 3 countries registered in a category. In case of such a cancelation, the LOC must reimburse, in full, the entry fee and
	payments made for accommodation. Should flights have to be cancelled due to the above, the risk is at the charge of the participating member Federations.
SIZE OF THE DELEGATION AND FIG LICENSE	The number of participants by nation, category and age group is not limited. All AG1 (12-14 Years), Juniors / AG2 (15-17 years) and Seniors gymnasts in good standing with the correct age and holding a valid FIG license until the end of the event, may participate. The LOC will be responsible for checking the validity of all gymnasts Licenses. No gymnasts will be accepted without a valid FIG License at the deadline of the Nominative Registration.
CATEGORIES	IW / IM / Mix Pair / Trio / Group (all age limits) / Aerodance (AG1, AG2 & SNR)
DRAWING OF LOTS	The drawing of lots will take place at the Gymnastics Federation of Portugal Federation two weeks after the closing date of the nominative registration. After publication of the draw to all participating federations there will be an opportunity to modify the position of the gymnasts' starting order within 3 days by using the official document.
MEDICAL SERVICES	The Local Organizing Committee will provide first aid medical services. A physiotherapist will be present during the competitions as well members of the Portuguese Red Cross specialized in first aids. Medical support is also available at 5 min. distance.
COVID 19	 Besides the FIG medical guidelines for the particular event, FIG also requires all the participants to follow the standard precautions. The FIG requires all participants, judges and officials to take standard precautionary measures, such as frequent hand-washing, wearing masks or face coverings at all times and keeping a physical distance of at least 1.5 metres whenever possible. The only situation in which the safety distance does not have to be respected is when a coach provides assistance (catch, lead, spotting) during an athlete's performance. This phase must be kept as short as possible and the assisting person is obliged to wear a mask throughout. Gymnasts do not need to wear a mask or face covering while they are performing at the training venue or on the FOP and keeping a physical distance of at least 1.5 metres 1.5 metres
VISA	Please verify immediately with your travel agent or the Portugal Embassy or Consulate in your country if a visa is required for your travel to Portugal . The Organizing Committee will be happy to assist each Delegation member with an official invitation letter, provided that the request is made before 19 , January , 2022 to the LOC. The request must include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the Delegation Member as well as the city the visa application support letter must be sent to.
INSURANCE	The Host Federation, the Organizing Committee and the FIG will not be held responsible for any liabilities in case of accidents, illness, repatriation and the like. The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid

	insurance coverage against illness, accidents and for repatriation for all the members of their Delegation.
	The LOC will verify the insurance upon arrival of the delegation members (e.g. cover note or photocopy of the valid policy). Delegation members with insufficient insurance cover must inform the LOC in advance.
